- Ref:- Order dated 25.01.2023 in OP. No.76/2022 of the Hon'ble Kerala State Electricity Regulatory Commission.

The Hon'ble KSERC has vide its order dated 25.01.2023 in OP. No.76/2022 directed to collect fuel surcharge @ ₹0.09 per unit in addition to the energy charge for the consumption from 01.02.2023 to 31.05.2023. It has also been ordered that the distribution licensees also collect fuel surcharge from their consumers and remit the amount promptly to KSEBL on a monthly basis. A statement showing category of consumer and amount collected may also be forwarded to this office for accounting the same and informing the Hon'ble KSERC.
