3. Minimum Qualification Criteria

- (i) The bidder should have experience of having successfully completed the works of providing vehicles on hire(Wet/Dry) to any Govt./PSU/ Reputed Private organizations for at least one year during last 7 years ending last day of the month previous to one in which applications are invited. Experience may be as per any of the following conditions given below. Copies of work orders and satisfactory performance certificate issued by the client should be furnished along with the tender. In the case of works executed for Private organizations a TDS certificate in connection with the contract to be produced.
- a. Experience in three similar works i.e providing vehicles on hire(wet/dry) each costing not less than Rs. 1,87,200/-
- b. Experience in two similar works i.e providing vehicles on hire(wet/dry) each costing not less than Rs.2,34,000/-
- c. Experience in one similar work i.e providing vehicles on hire(wet/dry) costing not less than Rs. 3,74,400/-
 - (ii) Average annual Financial turnover of the bidder during the last three financial years ending **31-03-2019** shall not be less than Rs. 1.4 lakhs. Financial Turnover for three years duly certified by a Chartered Accountant shall be furnished.
