The bidders need to obtain one time User ID & password for log-in to e-tendering portal www.tenderwizard.com/COPT from the service provider KEONICS, by paying registration amount of Rs.1180/-through online Payment using Credit/Debit Card/Net banking. - 5. Price should be quoted in the price schedule, attached as a separate excel sheet in the e-tender portal.

- 7. RFQ should be signed and stamped on all pages by the bidder as a token of acceptance and to be uploaded in to e-tendering portal.

- 8. Price quoted should be for supply of "**P-Bracket**" at Cochin Port Trust Stores. The rate quoted should be inclusive of freight charges, duties etc: Terms like 'payable at actual', 'Extra as applicable' etc: should not be included in the offer.
- 9. Manufacturing process should be done under IRS inspection/approval.
- 10. IRS Inspection charges will be borne by Cochin Port Trust.
- 11. Drawing of P- Bracket is attached at page No.03.
- 12. Validity of offer: **60 days** from the date of opening of Quotation.
- 13. Rates quoted should be strictly as per unit specified.
- 14. GST rate (%) applicable for the product should be shown separately.
- 15. Tenderer should have GST registration.
