### **SECTION I - NOTICE INVITING TENDER**

Electronic Tenders (e-tenders) in Single Stage Two Cover bidding procedure [Technical Bid and Financial Bid], are invited by the Chief Mechanical Engineer, Cochin Port Trust, Willingdon Island, Cochin-682009 from reputed firms meeting the Minimum Qualification Criteria specified below for "Supply, Installation, Testing and Commissioning of Vertical Turbine Jockey Pump, Auto Pump Selection Control System, Pressure Switches System and Interconnection with the existing Starter Panel and Engine Control Panel at NTB/STB Pump House at Cochin Port".

- 1. **Minimum Qualification Criteria** (**MQC**): Tenderer shall fulfill the following Minimum Qualification Criteria to prove the techno commercial competence and submit the documents in support thereof:
- 2.1.<u>Experience</u>: The tenderer should have successfully completed similar works during the last seven years ending 30-09-2021 to the Government Organizations / Private Organizations.
- 2.1.1. Three similar completed works each costing not less than Rs. 14,34,400/- OR
- 2.1.2. Two similar completed works each costing not less than Rs. 17,93,000/- OR
- 2.1.3. One similar completed work costing not less than Rs. 28,68,800/-
- 2.2.List of documents to be furnished to establish MQC stated at 2.1. above:
- 2.2.1. Copies of work orders and completion certificate for having satisfactorily supplied, installed and commissioned Fire fighting pumps and accessories with work order number and value of the item(s).
- 2.2.2. Similar Works means Supply and installation of Fire fighting pumps and accessories.

#### 2.3. Financial Turnover

- 2.3.1. Average Annual Financial Turnover of the tenderer during the last three financial years, ending 31<sup>st</sup> March, 2020 (viz. 2017-18, 2018-19 and 2019-20) shall not be less than **Rs.10,75,800/-.**
- 2.4. Explanatory Notes:
- 2.4.1. Following enhancement factors will be used for the costs of contracts executed for bringing the financial figures to a common base value in respect of the contracts completed in past years.

- 2.4.2. Satisfactory execution of Supply and installation of Fire fighting pumps to private organizations will be considered for qualification, only on submission of TDS certificate.
- 2.4.3. Bidder should submit the following documents along with the tender to prove the MQC:
  - (i) Self-attested / notarized copies of Work Order and Completion Certificate issued by the Client in support of contracts having been executed as proof. Details of such contracts shall be furnished as per Annexure-3.
  - (ii) A statement duly certified by the Chartered Accountant showing the Average Annual Financial Turnover during the last three financial years (viz. 2017-18, 2018-19 and 2019-20) and audited financial statements for the above three financial years.

# 2. Other Eligibility Considerations:

3.1 Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have (i) made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements; AND / OR (ii) record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.
