## COCHIN PORT TRUST EMPLOYEES (RECRUITMENT, SENIORITY AND PROMOTION) AMENDMENT REGULATIONS, 2018

In exercise of the powers conferred under Section 28 of the Major Port Trusts Act, 1963 (38 of 1963), the Board of Trustees of the Port of Cochin hereby makes the following Regulations further to amend the Cochin Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2010 namely:—

I. Short Title and commencement

- (i) These Regulations may be called "The Cochin Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2018"– (Recruitment Rules for Class III and IV posts)
- (ii) They shall come into force on the date of publication in the State Gazette.
- (iii) The Central Government has already given approval to the Board of Trustees of the Port of Cochin to make Regulations in respect of class III & IV posts vide Notification dated 28-10-2010 in the Gazette of India.
- (iv) This publication is made under Section 132 of the Major Port Trusts Act, 1963
- II. In the Schedule annexed to Regulation 5 of the Cochin Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2010, the Recruitment Rules of Class III & IV posts under Mechanical Engineering Department–
  - (1) All the entries for the post of Foreman (Power House) at Serial Number 195 shall be deleted.
  - (2) For the post of Driver Gr.V (ME) at Serial Number 226, the entries under Column No. 11 shall be substituted as under:—

"By promotion from the post of Driver Gr. IV (ME) in the scale of pay of 17700-44600 with 3 years regular service in the grade; failing which a combined regular service of 5 years in the post of Driver Gr. IV (ME) and in the post of Driver Forklift in the pay scale of 16300-38200 out of which 2 years regular service in the grade of Driver Gr. IV (ME) is essential and subject to passing the trade test."

(3) For the post of Driver Grp.IV (ME) at Serial Number 227, the entries under Column No. 11 shall be substituted as under:—

"By promotion from the post of Driver Forklift (ME) in the scale of pay of 16300-38200 with 3 years regular service in the grade; failing which a combined regular service of 5 years in the post of Driver Forklift (ME) and in the post of Greaser (M.E) in the pay scale of 14400-32300 out of which 2 years regular service in the grade of Driver Forklift (ME) is essential and subject to passing the trade test."

- (4) All the entries for the post of Driver Grade III (MC) at Serial Number 228 shall be deleted.
- (5) For the post of Foreman (Mechl.) Dry Dock at Serial Number 232-
  - (i) At Column No. 2, the words "(Please see Footnote 1 & 2)" may be inserted after the designation
  - (ii) the entries under Column No. 7 shall be substituted as under:-

"ITI/ITC (Motor Mechanic/Diesel Mechanic, Fitter, Welder, Sheet Metal worker/Blacksmithy, Carpenter) Certificate with 7 years experience in the supervisory capacity in the respective trade."

- (iii) The following may be inserted as Footnote
- "Footnote:—(1)The respective trades for the posts under the category of Marine Craft are Motor Mechanic/Diesel Mechanic and under the category of Fabricator are Blacksmithy and Sheet Metal worker.
  - (2) The posts coming under the Recruitment Rules for Foreman (Mechl.) Dry Dock (Sl. No. 232) are Foreman (Fitting), Foreman (Welding), Foreman (Fabrication), Foreman (Carpentry) and Foreman (Marine Craft)"

- For the post of Foreman (Mechl.) Workshop at Serial Number 233-
  - (i) At Column No. 2, the words "(Please see Footnote 3)" may be inserted after the designation
- (ii) the entries under Column No. 11 shall be substituted as under:-

"By promotion from the post of Asst. Foreman in the respective trades in the scale of pay of 21000-53500 with 2 years regular service in the grade; failing which a combined regular service of 5 years in the post of Asst. Foreman and in the post of HSK-I in the respective trades in the scale of pay of 19100-51100 out of which 1 year regular service in the grade of Asst. Foreman is essential

In the case of Foreman T & M—By promotion from the post of Turner & Machinist HSK-I in the scale of pay of `19100-51100 with 6 years experience."
