FILLING UP THE POST OF CHIEF MEDICAL OFFICER, COCHIN PORT TRUST ON DEPUTATION BASIS

1. Applications are invited for filling up the post of Chief Medical Officer in the scale of pay of Rs.43200-66000 (Pre-revised Rs. 18500-23900) in Cochin Port Trust on deputation basis from officers holding analogous posts or officers holding posts of Sr. Dy. Chief Medical Officer and equivalent specialists posts in the Scale of pay of Rs.16000-20800 (Rev- Rs.32900 – 58000) and above in Medical department with 3 years regular service in the grade in Govt./ Semi Govt./Public Sector Undertakings or Autonomous bodies. Normally the period of deputation will be for three years. Recruitment Rules attached as **(Annexure-I)**

2. Applications in the prescribed format **(Annexure-II)** from eligible and willing officers, who satisfy the eligibility criteria as per the recruitment rules for the post of Chief Medical Officer in Cochin Port Trust, may be forwarded through the employer along with the following documents so as to reach this office on or before 30.07.2015.

2. Attested copies of all certificates.
3. No-Objection Certificate of the respective organization.
4. An undertaking of the applicant not to withdraw, if selected.
5. Vigilance and Administrative clearance of the concerned organization

The applicant from Non-Port Sector should substantiate the equivalence of his/her pay scale to the requisite pay scale to prove the eligibility.

The applications received through proper channel only will be entertained. The applications received after the last date or without ACRs or otherwise incomplete will not be considered.
