Applications are invited for filling up the post of Financial Advisor & Chief Accounts Officer in the scale of pay of Rs.43200-66000 (Pre-revised Rs. 18500-23900) in Cochin Port Trust on deputation basis from officers holding analogous posts or officers holding posts of Senior Dy. Chief Accounts Officer and equivalent posts in the Finance Department in the scale of Rs. 16000-20800 (pre-revised) and above in Govt./Semi Govt./PSUs or Autonomous bodies with three years' regular service in the grade. Recruitment Rules attached as (**Annexure-I**). Normally the period of deputation will be for three years.

5. Vigilance and Administrative clearance of the concerned organization in the Proforma prescribed by the Ministry (**Annexure-III**).

The applicant from Non-Port Sector should substantiate the equivalence of his/her pay scale to the requisite pay scale to prove the eligibility. The Veracity of the Certificates produced by the applicants may be certified by the concerned organization.

The applications received through proper channel only will be considered. The applications received after the last date or without ACRs or otherwise incomplete will not be considered.

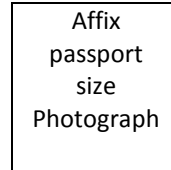
