Applications are invited for filling up the post of Financial Advisor & Chief Accounts Officer in the scale of pay of Rs.43200-66000 (Pre-revised Rs. 18500-23900) in Cochin Port Trust on deputation basis from officers holding analogous posts or officers holding posts of Senior Dy. Chief Accounts Officer and equivalent posts in the Finance Department in the scale of Rs. 16000-20800 (pre-revised) and above in Govt./Semi Govt./PSUs or Autonomous bodies with three years' regular service in the grade. The applicant from Non-Port Sector should substantiate the equivalence of his/her pay scale to the requisite pay scale to prove the eligibility. The Veracity of the Certificates produced by the applicants may be certified by the concerned organization.
