Sub:-Filling up the post of Sr.Dy.Chief Medical Officer in Cochin Port Trust.

Applications are invited for filling up the post of Sr.Dy.Chief Medical Officer in the scale of pay of Rs.32900-58000 at Cochin Port Trust by absorption through composite method. Officers holding analogous posts or holding the post of Dy. Chief Medical Officer (Specialist) and equivalent specialist posts in medical department in the scale of pay of Rs.24900-50500 (pre-revised Rs.13000-18250) with 3 years regular service in the grade in a Major Port Trust or Dy. Chief Medical Officer (Specialist) and equivalent specialist posts in medical department with 2 years regular service in the grade and a combined regular service of 7 years in the scales of pay of Rs.20600-46500(pre-revised Rs.10750-16750) and Rs.24900-50500 (pre-revised Rs.13000-18250) in specialist cadre of medical department in a Major Port Trust will be eligible. Recruitment Rules is attached as **Annexure-I**. The requisite educational & other qualifications prescribed as per RR are as under :-

- (i) MBBS degree from a recognized university.
- (ii) A post Graduate (PG)Medical Degree or PG Medical Diploma in the specified speciality from a recognized University.
- (iii) Post qualification experience of 10 years in case of PG Degree holders and 12 years experience in case of PG Diploma holders in the relevant field of specialization in a reputed hospital.

2. Applications in the prescribed format (**Annexure-II**) from eligible and willing Medical officers, who satisfy the provisions of Recruitment Rules for the post of Sr. Dy. Chief Medical Officer, may be forwarded along with the following documents so as to reach this office on or before **04.06.2018**.


- a) Attested copies of ACRs of the applicant for the last 5 years (Attested by an Officer not below the rank of Dy. HOD on each page).
- b) Attested copies of all certificates.
- c) No-Objection Certificate of the respective Ports.
- d) An undertaking of the applicant not to withdraw, if selected.
- e) Certificate by Head of Office of the Applicant
- f) Vigilance and Administrative clearance of the concerned Port in the Proforma prescribed by the Ministry (**Annexure-III**).

The Veracity of the University Certificates produced by the applicants and the recognition of the degree obtained by the applicant may be ensured and certified by the concerned Port.

The applications received through proper channel only will be entertained. The applications received after the last date or without ACRs or otherwise incomplete applications will not be considered.
