**COCHIN PORT TRUST ON DEPUTATION BASIS**

Applications are invited for filling up of one post of Sr.Dy.Chief Medical Officer in the scale of pay of Rs. Rs.32900-58000 (Pre-revised Rs. 16000-20800) in Cochin Port Trust on deputation basis from the “*officers holding analogous posts or holding posts of Dy.Chief Medical Officer(Specialist) and equivalent specialist posts in the scale of pay of Rs. 24900-50500(pre-revised Rs.13000-18250) in medical department in a Govt./ Semi-Govt./ PSUs or Autonomous bodies with 3 years regular service in the grade.* Normally, the period of deputation will be for three years. Recruitment Rules attached as **Annexure-I**.

Applications in the prescribed format (**Annexure-II**) from eligible and willing officers, who satisfy the provisions of recruitment rules for the post of Sr. Dy. Chief Medical Officer, may be forwarded through the employer along with the following documents so as to reach this office on or before **17.09.2018**.

1. Attested copies of ACRs of the applicant for the last 5 years (Attested by an Officer not below the rank of Dy. HOD on each page).
2. Attested copies of certificates of academic qualification & experience to prove eligibility.
3. No-Objection Certificate of the respective organization.
4. An undertaking of the applicant not to withdraw, if selected.
5. Vigilance and Administrative clearance of the concerned organization in the Proforma prescribed by the Ministry (**Annexure-III**).

The applicant from Non-Port Sector should substantiate the equivalence of his/her pay scale to the requisite pay scale to prove the eligibility. The Veracity of the Certificates produced by the applicants should be certified by the concerned organization.

The applicants should have at least 3 years service left as on 01.01.2019 for retirement on superannuation in the parent organization for deputation posting.

The applications received through proper channel only will be considered. The applications received after the last date or without ACRs or otherwise incomplete will not be considered.

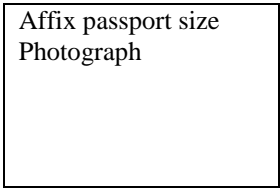
