COCHIN PORT TRUST NOTIFICATION

The following regulations approved by the Central Government and published in the Gazette of India is republished as per 132 Sub-section (2) of Major Port Trust Act, 1963 (38 of 1963) for general information.

New Delhi, the 25th October, 2014

G.S.R. 849(E).—In exercise of the powers conferred by sub-section (1) of section 124, read with sub-section (1) of section 132 of the Major Port Trusts Act, 1963 (38 of 1963), the Central Government hereby approves the Cochin Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2014 made by the Board of Trustees for the Port of Cochin and set out in the Schedule annexed to this Notification.

The said regulations shall come into force on the date of publication of this Notification in the Official Gazette.

**COCHIN PORT TRUST EMPLOYEES (RECRUITMENT, SENIORITY AND PROMOTION)
AMENDMENT REGULATIONS, 2014**

In exercise of the powers conferred by Section 28 of the Major Port Trusts Act, 1963 (38 of 1963), the Board of Trustees of the Port of Cochin hereby makes the following regulations to amend the Cochin Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2010, namely:—

1. (i) These Regulations may be called the Cochin Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2014.
- (ii) They shall come into force on the date of publication of the approval of the Central Government as required under the provisions of Section 124 and 132 of Major Port Trusts Act, 1963 in the Gazette of India.

2. In the Cochin Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2010, in the Schedule, for the post of Dy. Chief Vigilance Officer:—

- (i) the entries under Column No. 11 shall be substituted by the words, “By deputation.”
- (ii) the entries under Column No. 12 shall be substituted by the following:—

“Deputation from officers of Major Port Trusts holding posts in the pay scale of Rs. 20600-46500 (Rs. 10750-16750 pre-revised) with 3 years regular service in the grade failing which from officers of the Central Government/State Govt./PSUs/Autonomous Bodies with similar grade”.
