1.1. Electronic Tenders (e-Tenders) in "Two Cover System" are invited for **"The supply of one no motor launch on hire for CISF Harbour Patrol"** for a period of two years by the Deputy Conservator, Cochin Port Trust, Willingdon Island, Cochin – 9 and will be received **up to the time schedule**. Tenders shall be submitted in accordance with the 'E-Tender Notice ,Instruction to Tenderer , scope of work & special conditions of contract , General Conditions of Contract ' etc, as detailed in the Tender Document. The Tenders will be opened online by the Deputy Conservator, Cochin Port Trust (CoPT) at this office on the same day at **the scheduled time**. Only GST registered vendors will be eligible to participate in the Tender.

1.5. The Tender shall be submitted by an individual or by a Registered Partnership firm or by a Limited Company. **The name and address of the Tenderer shall be entered in the space provided in 'Price Bid'**. In the event of the Tender being submitted by a registered partnership firm, it must be signed individually by each partner thereof. In the event of absence of any partner, it must be signed on his behalf by the person holding a proper power-of-attorney, authorizing him to do so and to bind the partner in all matters pertaining to the contract including the arbitration clause, such power-of-attorney to be attached with the Tender which must disclose that the firm is duly registered under Indian Partnership Act. In the case of a Limited Company the Tender should be accompanied by the Memorandum and Articles of Association of the Company. **Joint Venture is not allowed in the Tender.**
