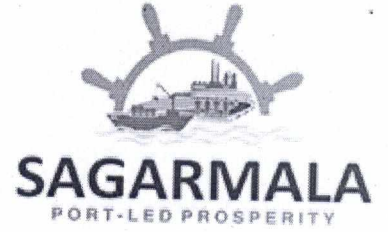

QUOTATION

Sub : Quotations for managing the collection of parking fee at the temporary parking area earmarked on one side of the road from Kalamukku junction to LNG Terminal at Puthuvypeen.

--

Quotations are invited from firms having at least 1 year experience in collection of toll/parking fee, at terminals/ toll booths having daily collection of approximately Rs.5000/- for entrusting the collection of parking fee at the temporary parking area of Cochin Port Trust earmarked on one side of the road from Kalamukku Junction to LNG Terminal. The terms and conditions are given below:

1. The rate shall be quoted in the attached format only.
2. The collection of charges from the temporary parking facility is for a period of six months from **01.01.2021 to 30.06.2021**, unless otherwise extended by the Competent Authority.
3. The area for parking will be as earmarked by CISF on one side of the road from Kalamukku junction to LNG Terminal (300 meters away from the boundary wall of LNG Terminal).
4. The rates applicable, as decided in the meeting of the Dist. Collector dt. 30.07.2019 as given below.

Rates per 24 hrs.

20ft Trailers	-	Rs. 120.00
40 ft Trailers	-	Rs. 200.00

(Additional charges payable after 24 Hrs of parking is Rs.120/200 per day, as applicable)

5. The party will have to arrange manpower to collect the fee from the trailers / trucks which arrive LNG Road (due to non-availability of parking space at the three parking terminals at Bolgatty and Vallarpadam) and remit the collected amount to the Cochin Port Trust account on daily basis, through online, under intimation to designated officer in Cochin Port Trust.

6. The vouchers for collection of fee will be provided by Cochin Port Trust, Duplicate copy of the vouchers will have to be maintained by the representative of the party for verification by officials of Cochin Port Trust / CISF, as and when required.
7. Service charge payable by Cochin Port Trust (i.e., % of amount collected by the party and remitted to CoPT accounts) may be quoted in the attached format. The rate quoted will be valid for a period of 2 years.
8. The lowest quotee will be engaged by Cochin Port Trust to manage at the temporary parking area being arranged at designated area at Kalamukku – LNG Road. Subject to deposit of a refundable security deposit of Rs.25,000/- and signing of agreement.
9. The service charge as agreed to will be paid by Cochin Port Trust to the successful bidder on completion of one month on submission of relevant documents in support of the claims.
10. Cochin Port Trust reserves the right to cancel/extended the contract, once entrusted to the selected party.
11. The filled up bid format may be submitted to Secretary, Cochin Port Trust, Cochin-9 before **3 P.M. on 23.12.2020**
12. The contractor will be responsible for compliance all statutory requirements of manpower engaged for the collection of parking fee including their safety and security.
