Cochin Port Trust is carrying out the dredging works in the approach channels and berth basins under Lump sum need basis for maintaining required depths and widths at Outer Approach Channels, Inner Approach Channels and various berths for the year 2021-2022. In order to monitor the on-going dredging activity, it is proposed to invite competitive tenders from the reputed consulting firms for engaging as Third-Party Certification / Survey Agency. The services of Certification cum Survey Agency is to carry out (a) monitoring / supervision of maintenance dredging and (b) witnessing and certifying hydrographic / bathymetric survey at channels and inner harbour of Cochin Port by engaging manpower. The period of contract shall be for a period of one year and likely to be extended for another period of two years on the same terms and conditions, at the discretion of CoPT and based on the Performance of the Agency.

5. Outsourcing / Subcontracting is not permitted for this Assignment.

- 6. Bid Documents can be downloaded from the e-Tendering portal www.tenderwizard.com/COPT on the dates specified in the above table by making online requisition. Bid Document will also be available in Cochin Port website (www.cochinport.gov.in) as well as Central Public Procurement (CPP) Portal which can be downloaded for submission. The cost of Bid Document shall be furnished in the form of Demand Draft/ Pay Order/Banker's Cheque drawn in favour of FA & CAO, CoPT along with the submission of Bid. Payment can also be made online mode (NEFT/RTGS) as per Bank details at *Annexure-16*. The bidders shall upload the proof of payment made towards cost of tender document along with the Bid Document while submitting the tender electronically in the e-Tendering Portal.
- 7. The bids shall be uploaded in electronic form only through e-tender portal www.tenderwizard.com/CPT.
