NOTICE INVITING BUDGETARY INQUIRY

BACK GROUND.

Cochin Port Trust proposes to construct an additional jetty of 200m length in continuation to the newly constructed Jetty for berthing defence vessels at Fort Kochi in Mattancherry channel of Port, for Indian Coast Guard, on deposit work basis. CoPT has allotted water area in the Mattancherry channel adjacent to Old Workshop at Fort Kochi for the construction of jetty. The layout plan of the proposed jetty is attached as **Annexure-I**. The proposed construction involves main jetty of size 200m x 4m wide jetty with 7 nos. of Breasting Dolphins of size 8m x 8m resting on bored cast in situ piles of 1.0m dia.

Port is in the process of preparing the detailed estimate for the project. It is proposed to invite tenders for the work within a period of six months and the period of contract will be about 12 months. In this regard, you are requested to furnish your budgetary rates for the items connected with proposed Jetty construction as per the items attached at **Annexure-II** to the Chief Engineer, Cochin Port Trust (ce@cochinport.gov.in ; coptce@gmail.com), at the earliest please. The offered rates shall be inclusive of all taxes, duties and other contingencies, if any. GST will be paid extra. Rates quoted for items of pile foundation shall be inclusive of mobilisation of all equipments for installation of piles and there will be no separate item for mobilisation and demobilisation of plants and equipments. The work area of about 3000 m2 at a distance of 2km (Approx.) from the site via water body at W/Island near to Union Territory of Lakshadweep Jetty having water frontage will be made available, to the contractor free of rent.

The bidders are requested to submit the **Budgetary rates** as per **Annexure-II** attached and may be sent in sealed cover superscribing “ Budgetary Rates for the Additional Jetty of 200m length in continuation to the newly constructed Coast Guard Jetty” , to the Chief Engineer, Cochin Port Trust at the address given above so as to reach us on or before **05-03-2022 at 17:00 hrs.**

The bidders may note that the rates are invited only for **budgetary** purpose. Cochin Port is not bound to award the work to any bidders based on the **budgetary** rates submitted. Cochin Port Trust will not be liable for any financial obligation to the bidders in connection with the preparation of his budgetary rates.
