Sir,

Sub:-Filling up the post of Chief Engineer in Cochin Port Authority.

The post of Chief Engineer in the scale of pay of Rs.1,00,000-2,60,000 in Cochin Port Authority will fall vacant w.e.f. 01-04-2023 consequent to the superannuation of the incumbent. Accordingly, applications are invited for filling up the post of Chief Engineer, in the scale of pay of Rs.1,00,000 -2,60,000 in Cochin Port Authority by absorption through composite method from Officers holding posts in the scale of pay of Rs.80,000 – 2,20,000 with three years regular service in the grade in Civil Engineering Department of a Major Port. The copy of Recruitment Rule is enclosed as Annexure–I.

2. The requisite educational & other qualifications prescribed as per RR, are as under:-'Degree or equivalent in Civil Engg. from a recognised University/ Institution '

3. The selection is by merit for which the benchmark in overall grading in the ACRs will not be below "Very Good".

4. The eligible and willing Officers from Major Ports who satisfy the provisions of Recruitment Rule for the post of Chief Engineer shall apply through the "Online Application Portal (OAP)' of the Ministry of Ports, Shipping & Waterways <u>https://onlinevacancy.shipmin.nic.in</u>). The applicant has to register in the Online Application Portal. No application other than OAP shall be accepted.

5. The candidate shall submit the print out of online application submitted via OAP.

6. The Administrative Ports are requested to forward the application through proper channel along with the following documents in an envelope, superscribing *'Application for the post of Chief Engineer in Cochin Port Authority on absorption basis'*, to the Secretary, Cochin Port Authority, Willingdon Island, Cochin-682 009 so as to reach on or before **25.11.2022**

- i. Attested copies of Annual Performance Appraisal Reports (APARs/ACRs) of the applicant for the last 5 years (01.04.2016 to 31.03.2021) (Attested by an Officer not below the rank of Dy. HOD on each page).
- ii. A statement showing year-wise availability of APARs/ ACRs and grading duly signed by the Competent Authority. If the APAR for a particular period during the last 5 years is not available, "No Report Certificate" may be furnished along with the APARs of preceding years.
- iii. Attested copies of all Certificates and proof of educational qualification, present and past work experience in the respective post and pay scale.
- iv. No-Objection certificate of the concerned Port.

- v. An undertaking of the applicant not to withdraw his/her candidature, if selected. Officials, who withdraw his/her candidature for the Post after his/her selection by the Services Selection Committee, will be liable for debarment from future selection to HOD level posts in all Major Ports for a period of two years.
- vi. Certificate by Head of office of the applicant as per Annexure-II.
- vii The vigilance status of the candidates may be furnished in the prescribed Proforma duly signed by the CVO of the concerned Port along with the application (Annexure-III). If any major or minor penalty has been imposed on the applicant during the last 10 years, the disciplinary case leading to such penalty along with necessary documents may be sent by the forwarding authority along with the application.

viii. Two recent passport size photographs in a sealed envelope.

- ix. The details of the applicant, length of service in feeder grade posts with pay scales, final APAR gradings and eligibility position may be confirmed and clearly indicated by the Ports.
- x. The Veracity of the University Certificates produced by the applicants and the recognition of the degree obtained by the applicant shall be ensured and certified by the concerned officer of the Port.

7. The crucial date for eligibility criteria will be **01.04.2023** in terms of Ministry of Ports, Shipping & Waterways Circular No.I-26/25/2013-PE-I dated 26.09.2019.

8. In case of receipt of advance copy of application in respect of any applicant by the Port, his/her candidature will not be considered if the application is not received through proper channel within 15 days of last date of receipt of application, mentioned at SI. No.6 above.

9. Incomplete applications or applications not submitted as per the instructions of this vacancy circular will not be considered.
