The tender can be submitted up to 10:00 hrs on 15.02.2024. The price bid will be **opened at 11:00 Hrs on 15.02.2024.**

The Tender notice and the list of registered vendors are available in the website www.cochinport.gov.in and Central Procurement Portal (CPP) http.eprocure.gov.in. Only vendors registered with Cochin Port Authority can participate in the E-tender.

The firms registered with Cochin Port Authority need to renew or obtain their one time User ID & password for log-in to the e-Tendering system, which can be obtained from the service provider M/s. KEONICS (Karnataka State Electronics Development Corporation Limited) by paying a registration fee of Rs.1,180/- (Rupees One thousand one hundred and eighty only), by online payment through credit card/Debit card/Net Banking .

Manufacturers/Pharmaceutical companies /Distributors of Lab items/ X-Ray & ECG items/ Tinctures & Chemicals/ Surgical suppliers registered with Cochin Port Authority will have to acquire Class III digital signature for registering.
