- iii. iii) Insurance Surety Bond from the Insurance Company duly approved by Insurance Regulatory and Development Authority of India.

You are also requested to execute an agreement on a Kerala State stamp paper worth Rs.200/- (Rupees Two hundred only) in the prescribed departmental form, which is available in the office of the undersigned, within **21 days** from the date of receipt of this order.

You are further requested to contact the Superintending Engineer- II of this Port Authority immediately and start the work within **7 days** from the date of receipt of this order. The contract will be in force for a period of **1 (one) year** from the date of commencement of work.
