1. Your tender for the subject work has been accepted at 0.50% less than the departmental Estimated amount, which works out to a contract value of Rs. 9,16,379.08 (Rupees Nine Lakh Sixteen thousand Three hundred Seventy Nine and paise Eight only [Excluding GST]).

2. You are requested to furnish a Performance Security of Rs. 46,000/- (Rupees Forty Six Thousand only) which is 5% of the contract value in one of the following forms, within **14 days** from the date of receipt of this work order; as per **Clause 13.1, 13.2 & 13.3** of the Notice Inviting Tender of Departmental Tender Document.

- ii. An irrevocable Bank Guarantee(BG) enforceable and encashable at Cochin, drawn from any Scheduled Bank operating in India as per the prescribed proforma attached as Annexure V.

iii. Insurance Surety Bond from the Insurance Company duly approved by Insurance Regulatory and Development Authority of India.

3. You are also requested to execute an agreement on Kerala State stamp paper worth Rs. 200/- (Rupees Two hundred only) in the prescribed departmental form, which is available in the office of the undersigned, within **21 days** from the date of receipt of this work order.

4. You are further requested to contact the Suptdg. Engineer (II) of this Port Authority immediately and take over the site and start the work within **7 (seven)** days from the date of receipt of this work order and complete the work within **6 (Six) Months** from the date of commencement of work.
