Text of RTI First Appeal :

My initial application was for the following: It is kindly requested to forward the list of Surveyor entities and individual surveyors permitted to work in the Cochin port along with soft copy of their port passes and credentials based on which the pass is issued to them for the last 2 years 2021-22 and 2022-23. Whereas I have been given only the list of Surveyor companies permitted to work in the CPT for 2021 & 2022 and list of surveyors of these companies, individual surveyors and their credentials has not been shared citing Section 8(1) (j) of RTI Act 2005 being third party information. Considering that the information cannot be shared, request to share the following:

- 1. Only number of surveyors issued with port entry pass of the respective surveyor companies (9 Companies in 2021 and 14 Companies in 2022) and if all the companies in the list qualifies to work.
2. Qualification / license mandated by CPT to issue surveyor port entry pass.
3. Regulation followed by CPT to monitor the conduct and duties & responsibilities of cargo surveyors.
4. Reason / Logic for permitting cargo surveyors to work in CPT.

ORDER

1. An RTI Application dated 28.03.2023 was filed by the Appellant seeking to furnish the list of Surveyor entities and individual surveyors permitted to work in the Cochin Port along with soft copy of their port passes and credentials based on which the pass is issued to them for the last 2 years 2021-22 and 2022-23. The CPIO vide reply dated 28.04.2023 furnished the list of Surveyor companies permitted to work in the CPT for 2021 & 2022 and denied the soft copy of passes and credentials based on which passes have been issued citing Section 8(1) (j) of RTI Act 2005, being third party information.


2. Aggrieved by the CPIO's reply, the Appellant filed the RTI Appeal dated 30.04.2023 stating that he was provided only with the list of Surveyor companies permitted to work in CoPA and not provided with the list of Surveyors of this company, individual surveyors and their credentials. Stating so, the Appellant has made some fresh queries in his appeal, viz., 1) Only number of surveyors issued with port entry pass of the respective surveyor companies (9 Companies in 2021 and 14 Companies in 2022) and if all the companies in the list qualifies to work 2) Qualification/license mandated by CPT to issue surveyor port entry pass 3) Regulation followed by CPT to monitor the conduct and duties & responsibilities of cargo surveyors and 4) Reason/Logic for permitting cargo surveyors to work in CPT.

3. It is seen that the appellant seeks additional information by raising new queries and request for new documents at the appeal stage, which is not proper, neither the intent of the Appeal provision.

4. The Appeal is thus dismissed.

5. Second Appeal, if any, against the above decision shall lie within ninety days from the date of receipt of this communication, with the Chief Information Commissioner, whose name and address are given below:
