1. An RTI Application dated 14.07.2022 was filed by the appellant Shri. P.K. Joseph, Puthettu House, 8/98B, Ollaril Road, Panangad P.O, Kochi-682 506, seeking copies of communication between the Cochin Port Authority and the Ministry of Ports, Shipping & Waterways regarding exgratia payments to SVRS Retirees, to which reply was given by the CPIO on 26.08.2022 denying the information citing that these communications are considered confidential till a final decision is taken in the matter and that the concerned section will be able to provide the documents after a final decision is taken in the matter by the concerned authorities.

- 2. Aggrieved by the CPIO's reply, the appellant preferred an appeal before the First Appellate Authority vide his appeal dated 28.09.2022, wherein the appellant has contended that the information requested are purely connected with Special VR Scheme (SVRS) implemented on 2017 and that he has a right to know about the communication by CoPA with Ministry as he is a beneficiary of the scheme.
- The Appellant was given opportunity of hearing, which he denied vide his mail dated 21.10.2022. Accordingly, the appeal was examined without affording any hearing. The CPIO was also given an opportunity to make submissions wherein the stand taken denying the information as confidential until a finality to the issue is arrived at was affirmed.
- I have examined the appeal and is of the view that the communication sought by the Appellant are to be considered as confidential till a final decision in the subject matter is made and furnishing them at this stage may prejudice the decision making process. The documents may be considered to be provided upon arriving a finality on the matter.
- The Appeal is disposed off as above.
