Hence the information cannot be disclosed as the same comes under Section 8(1) (j) of RTI Act, 2005.

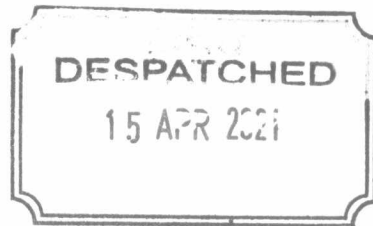
The appeal is disposed off as above.
