CIRCULAR

Sub:- Payment of advance as Productivity Linked Reward to the Port employees/workers working in Cochin Port Trust for the year 2020-21 – reg.

Productivity Linked Reward payable to Port Employees is extended only after the same is declared by the Ministry/IPA every year before festive season. This year, however, PLR for the year 2020-21 is yet to be declared by the IPA/Ministry.

Therefore, as per the decision taken in the Special meeting of IPA Governing Body on 25.10.2021 and also considering the request of the local Trade Unions, the Chairman, Cochin Port has accorded approval for payment of interest free Productivity Linked Reward advance amounting to Rs.16423/- only in r/o. CoPT employees which is equal to the last year 2019-20.

The above interest free Productivity Linked Reward advance amounting to Rs.16423/- (Rupees sixteen thousand four hundred and twenty three) only will be paid to all employees/Officers/Workers who will be on roll as on 01.01.2022.

The said advance would be adjusted against PLR for the year 2020-21 if any, declared by IPA/Ministry within 31.12.2021, failing which the amount would be recoverable in 10 equal monthly installments starting from the salary of January 2022.

Accordingly, it has been decided to release the PLR to employees/Officers/Workers of Cochin Port Trust on 03.11.2021.
