

The Ministry of Shipping has also ordered vide No. SW-14020/5/2009-MG/SA (Vol.9) dated 22.05.2018 that Section 407 (1) of the Merchant Shipping Act, 1958 shall not apply to foreign flag ships engaged in the Coasting Trade of India for carriage of a specified list of Agricultural, Fisheries, Animal Husbandry and Horticultural commodities, subject to specified conditions. |
