RECORD NOTE OF PROCEEDINGS OF THE MEETING HELD ON 03.01.2015 AT 11.00 a.m. IN THE CHAMBER OF FA & CAO TO DISCUSS PROMOTIONAL OPPORTUNITIES TO EDP STAFF OF COMPUTER CENTRE, FINANCE DEPT. OF COCHIN PORT TRUST, WITH UNION REPRESENTATIVES.

At the outset, FA & CAO welcomed the union representatives and officers to the meeting. He informed the gathering that two letters received from the unions containing the same subject would be taken up for discussion during the meeting. He requested the union representatives to present the case.

Sri. Mohammed Haneef pointed out that there is no Manager level post in EDP Division as recommended by Chakraborty Committee Report. Since the CC report had dealt with the matters relating to promotions of EDP staff, this subject was not taken up by Afsulpurkar Committee. However, CC Report is not implemented in Cochin Port Trust as far as EDP staff is concerned. He also

pointed out that when compared to the recommendations of Chakraborty Committee, EDP staff is enjoying certain higher scales at present. He requested that the scale of Sr. OCIOA (Rs. 21000- 53500) is to be upgraded to that of the Manager level (Rs. 23600 – 56300) as in the Committee Report, which would not have any financial implication since the incumbents have already attained this level due to grant of MACP.

Representatives of CHWU endorsed the views expressed by Shri Haneef and requested the FA to redress their grievance early.

FA responded that the 4 posts of Sr. OCIOA was made regular only very recently as they were project posts operated since 1998 in connection with the implementation of MIS and ERP projects. The employees of EDP division recently represented to him about this grievance and he had requested them to submit copies of the report enabling the management to consider their case favourably. Afsulpurkar Committee Report does not contain any such recommendations as rightly pointed out by Shri Haneef. However, the recommendations in the Chakraborty Committee as pointed out by Shri Haneef would be examined in detail and necessary action will be taken to redress the grievance based on such recommendations.

FA directed Sr. DD(EDP) and Sr. AO (Admn.) to examine this points in detail and submit their views on the matter. The conditions stipulated in Chakraborty Committee Report relating to similar post and qualification, etc. will also be considered at the time of examining the case.

The meeting was ended at 12.00 noon.

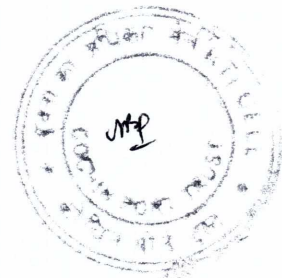


