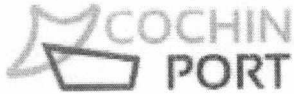

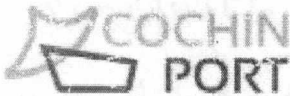

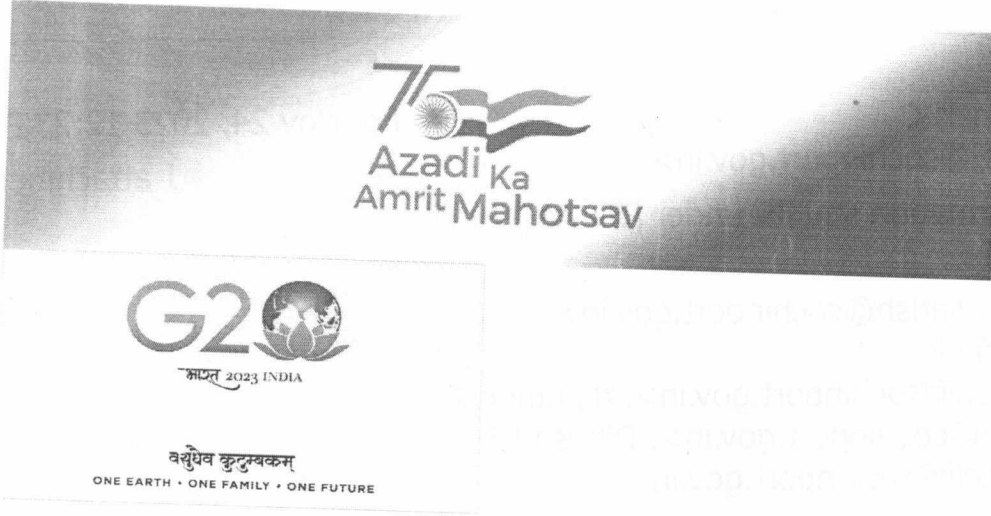

New Delhi, the 31st July, 2006

G.S.R. 451(E).—In exercise of the powers conferred by Section 3 of the Public Premises (Eviction of Unauthorised Occupants) Act, 1971 (40 of 1971) and in supersession of the Notification of the Government of India in the erstwhile Ministry of Surface Transport (Ports Wing), No. S.O. 401 (E) dated the 2nd May, 1995 except as respects things done or omitted to be done before such supersession the Central Government hereby appoints the Officer mentioned in Column (1) of the Table below, being officer of the Cochin Port Trust equivalent to the rank of Gazetted Officer of the Government of India, to be the Estate Officer for the purpose of the said Act, and who shall exercise the powers conferred and perform the duties imposed on the Estate Officer by or under the said Act, within the local limits of his jurisdiction in respect of the public premises specified in the corresponding entry in column (2) of the said Table :
