With reference to the above, information pertains to Cochin Port Trust is furnished below for forwarding to the applicant.

Query No. 1 - No Port land is under encroachment. Water body having an approximate extent of 0.4 Acres falling within the port limit at Panambukadu, Ernakulam was encroached by people living in the water front area, for the purpose of creating a road along the water frontage.

Query No. 2 - Encroached area has been demarcated to prevent further encroachment and CoPT propose to fence-off the area. A survey team from Revenue Department, Govt. of Kerala, is deputed to survey the area and to fix boundaries of private land as per revenue records of Govt. of Kerala.
