Trade Notice No.1/2020

Sub: Exemptions/remission of port charges on account pandemic COVID-19 related lockdown measures - reg.

- In order to support and rebuild the logistic chain which have been adversely impacted due to the COVID-19 pandemic and the lock down measures, the Ministry of Shipping (MoS), Government of India, have decided to grant some relief to the logistic chain related businesses including traders, importers, exporters, port operators, shipping lines, transporters, etc..
- MoS, vide their letter no. PD-14033/4/2020-PD VII dtd 21.04.2020 has directed to grant exemption/remission of charges levied on the port users during the <u>period of</u> <u>lock-down</u>, i.e., <u>from 22nd March to 3rd May 2020</u>, in exercise of powers conferred under section 111 of the Major Port Trusts Act, 1963.
- Accordingly, Cochin Port shall grant reliefs in port charges, as directed by the Ministry in their order under reference. M/s India Gateway Terminal Pvt. Ltd. (IGTPL) has also agreed to extend such benefit to the Trade and has also issued Trade Notice no.93 dtd. 23.04.2020 to this effect.
- 4. The members of the Trade fraternity are advised to comply with the stipulations as prescribed in the order of Ministry, in order to avail the benefits granted by the Ministry, including submission of specific requests within the stipulated time.
- 5. The Trade fraternity is hereby directed to pass on the benefit to their end-users.
- 6. The remissions/waivers/deferments stipulated shall be applicable only to port related activities, industries and commercial establishments.
- This order shall not be applicable to any captive user, Central or state Government entities, local bodies, PSUs, CPSEs.

8. In compliance with the directions of the Ministry of Shipping, the reliefs granted by Cochin Port are:

a. To the Port Users
