CIRCULAR

Sub: - Waiver of 'Shifting' (Pilotage) and Berth hire charges in respect of barges engaged by various oil companies for supply of bunkers and fresh water at anchorage of Cochin Port- reg.

The Board of Trustees of Cochin Port, in their meeting held on 05/02/2015, resolved, vide Agenda Item No. D-13 to approve for extending the following concessions to all the barges engaged in bunkering operations presently and for new barges which may be chartered/owned by oil companies in the next two years till 31st December, 2017.

- a) Waiver of 'Shifting' (Pilotage) charges for the barges registered under IV Act, MS Act or RSV type IV; and
- b) Waiver of berth hire charges for the barges registered under RSV Type IV, MS Act during monsoon period i.e from June to September.

The above concessions will also apply for the barges engaged in supply of fresh water at outer anchorage.
