CIRCULAR

1. Applications are invited from the parents of children who have been admitted in the listed stream of study during the academic year 2025-26 for higher education of children of employees under the scheme approved by Cochin Port Authority.
2. In addition to the above, parents of students who have taken admission in previous academic years and are continuing their studies in this academic year but were not able to apply for the scholarship in previous academic years can apply for consideration for the scholarship from the academic year 2025-26.
3. The sanctioned amount shall be paid in annual instalments as shown in the table.
4. Subject to other provisions of the Scholarship Rules, all categories of employees with two years of service are eligible to apply for these scholarships.
5. This benefit is not admissible to more than two children of employees at a time
6. Students receiving any other form of educational benefits are also eligible for this scholarship.
7. The name and location of the institution where the child is studying and the information regarding the recognition of the institution under the law should be shown separately in the application.
8. Applications should be submitted to the Drawing Offices of the applicants along with the mark list after filling up the prescribed form enclosed herewith with the signature of the school/college authorities. Applicants for professional courses should specifically indicate the name of course and duration of the course. Application form is available from drawing offices.
9. Those who want to know more information about the scholarship should inquire at the drawing offices or Welfare Section.(Extn. No. 2108)
10. Last date of receipt of applications **27-02-2026**. Applications received thereafter will not be entertained under any circumstances.
