- iii. Insurance Surety Bond from the Insurance Company duly approved by Insurance Regulatory and Development Authority of India

3. You are also requested to execute an Agreement on Kerala State stamp paper worth Rs.200/- (Rupees Two hundred only) in the prescribed departmental form, which is available

in the office of the undersigned, within 21 days from the date of receipt of this work order.

4. You are further requested to contact the **Executive Engineer (M)** of this Port Authority immediately and take over the site and start the work within **7 (Seven)** days from the date of receipt of this work order and complete the work within **8 (Eight) Months** from the date of commencement of work.
