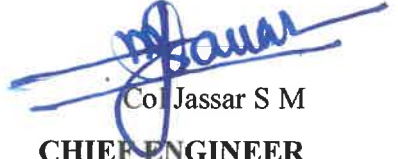
- i. Banker's Cheque/ Demand Draft/ Pay Order of a Scheduled Bank.
