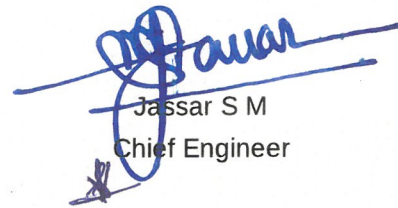

 - i. Banker's Cheque/ Demand Draft of a Scheduled Bank / Online Payment Through RTGS OR NEFT. If online payment is made, the evidence thereof shall be submitted to the office.
 - ii. An irrevocable Bank Guarantee (BG) enforceable and encashable at Cochin, drawn from any Scheduled Bank operating in India as per the prescribed proforma (**Annexure V**).
 - iii. Insurance Surety Bond from the Insurance Company duly approved by Insurance Regulatory and Development Authority of India
3. You are also requested to execute an Agreement on Kerala State stamp paper worth **Rs.200/-** (Rupees Two hundred only) in the prescribed departmental form, which is available in the office of the undersigned, within 21 days from the date of receipt of this work order.

4. You are further requested to contact the Executive Engineer (M) of this Port Authority immediately and take over the site and start the work within **7 (Seven)** days from the date of receipt of this work order and complete the work within **45 (Forty Five) Days** from the date of commencement of work.
