1. Sealed item rate quotations are invited on behalf of Cochin Port Authority, from specialised agencies for the following work:

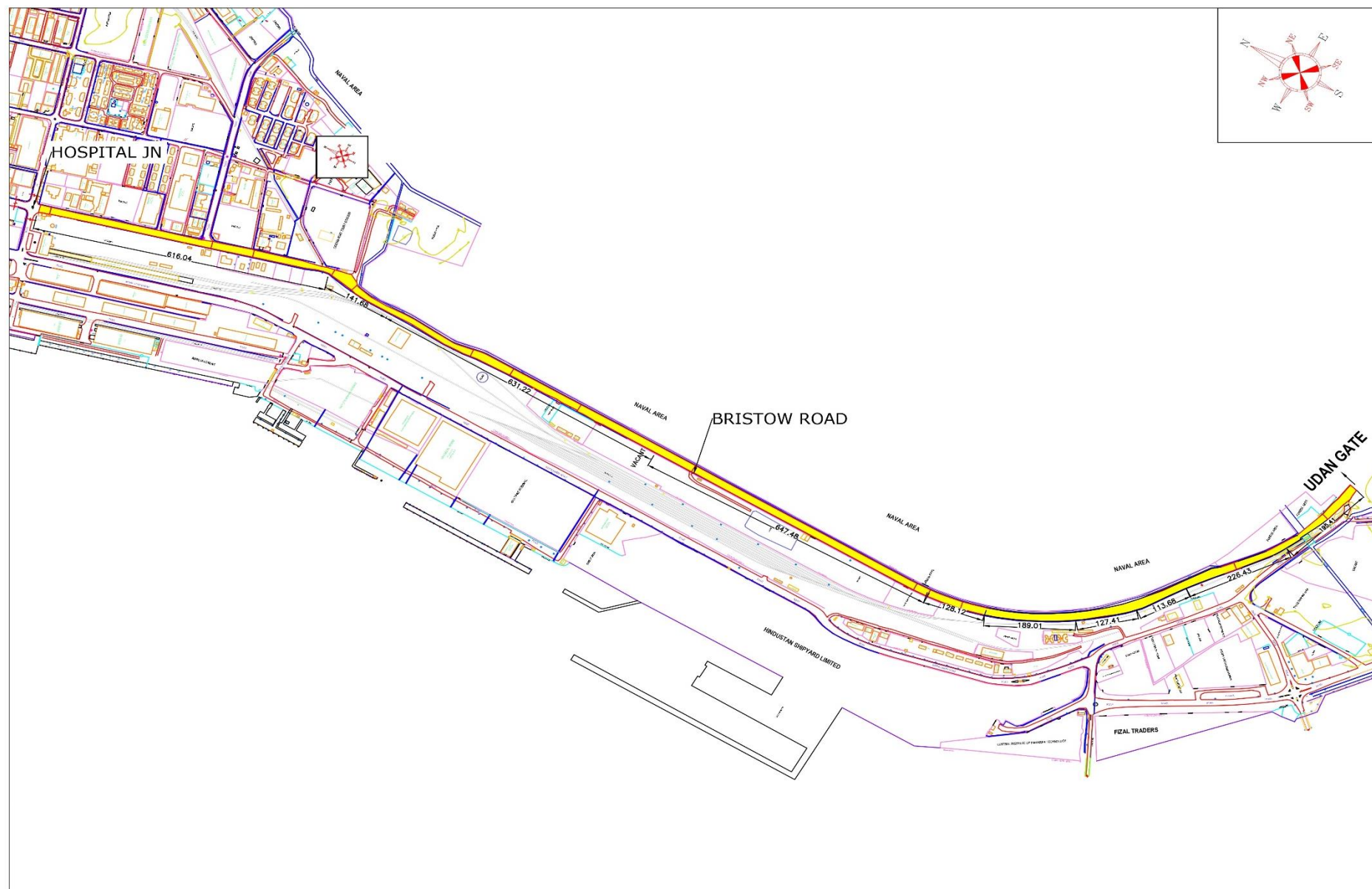

2. The hard copy of quotation signed and sealed attached along with this NIQ is to be submitted at the office of undersigned before the due date and time indicated above.
3. The quotations will be opened at 15.00 Hrs. on the same day.
4. Terms and Conditions:
 - (a) Minor site clearance, if any, will have to be made by the agency at the specified locations to enable to carry out the survey work.
 - (b) Security/ gate passes, if required, shall be arranged by CoPA and the field team shall be allowed unrestricted access to the site
 - (c) The survey work shall commence within 3 to 4 days on receipt of the work order.
 - (d) Survey work shall be completed within 3-4 days. This will also depend upon the site/ climatic conditions
 - (e) The topographic survey chart shall be submitted within 2-3 days on completion of survey.
 - (f) The rates to be quoted by the agencies shall be net (inclusive of all taxes) but excluding GST and GST will be paid extra as per the applicable rate.
 - (g) Final payment shall be made only after submission of the topographic survey chart.

- (h) Necessary recoveries as per Government rules will be effected from the bill.
 - (i) Time limit to complete the survey work is within 7 days after receipt of work order through email.
 - (j) The Department reserves the right to cancel the work order at any point of time during the work without assigning any reason.
 - (k) The Terms and Conditions as mentioned in the NIQ shall be signed by the intending Quotationers in the token of acceptance.
 - (l) The agency shall have valid GST registration No. and valid PAN card and, obtaining the same is the agency's responsibility, failing which, the delay in payment shall be the sole responsibility of the agency.
 - (m) Invoice towards payment shall be submitted on completion of all the works with all supporting documents to the undersigned and payment will be released within one week.
 - (n) The quotation, along with all the documents may also be submitted through e-mail to "thadevus@cochinport.gov.in".
